Economist. Lecturer, New College, Oxford, 1937. Fellow, University College, Oxford, 1938-45. Civil servant, 1940-45. Parliamentary Secretary, Ministry of Works, 1945-47. Secretary for Overseas Trade, 1947. President, Board of Trade, 1947-51. Leader of the Labour Party, 1963-76. Prime Minister, 1964-70, Feb.1974-76. O.B.E., 1945. P.C., 1947. K.G., 1976.

Attended Sunday School at Milnsbridge Baptist Church, Huddersfield, where owed much to the ministry of Rev. W. H. Potter (B.T., 22 Oct.1964, p.5). M.P.(Lab): Leicestershire, Loughborough, 1929-31

Schoolmaster. Active in National Union of (Elementary) Teachers. Secretary of Leicestershire and District Temperance Union. Member of Daily Herald staff, 1920-29.

Member of Melbourne Hall, Leicester, under Rev. F. B. Meyer and Rev. W. Y. Fullerton. Then joined a Manchester Congregational Church, and later Upper Warlingham Wesleyan Church, Surrey, where on the lay preaching plan. (B.T., 7 Nov.1924, p.729)

RT HON. SIR WALTER JAMES WOMERSLEY, Bart 1878-1961

M.P.(C): Grimsby, 1924-45

House furnisher, jeweller and general merchant. Councillor (from 1911) (from 1931) of Grimsby, and mayor, alderman Association of Municipal Corporations. Vice-president, Chairman, National Chamber of Trade. J.P. Parliamentary Private Secretary at Board of Education, 1931. Government whip, 1931-35. Postmaster-General, 1935-39. Minister of Pensions, 1939-45. Knight, 1934. P.C., 1941. Bart, 1945.

Reputedly a Baptist, but seemed to be ex-Baptist (Payne). Children attended Cleethorpes Primitive Methodist Sunday School (B.T., 12 Nov.1931, p.793). W.W.B.M.P., W.W.B.M.P., 3.

membership, but received back upon repentance the following year.

In the second half of the nineteenth century a sense of decorum leads to the church books containing only the most general description of disciplinary cases. For example, an entry dated 7th. February 1883 records that: 'Elizabeth Pavey's name was struck out and our prayer is that she may be led to repentance'.

The 1884 Annual Meeting, however, witnessed something of a disturbance. The record reads:

Whilst we were partaking of tea, Mrs. Robert French to the annoyance of all present, began to make a speech about a presentation to Mrs. Samuel French, but our pastor wisely prohibited her from doing so.

The following year, because of 'her unchristian conduct in every way trying to damage the pastor', she was not allowed to take any further part in church meetings, 'unless she confess her sorrow at what she has done and promise to amend'. But that kind of entry had by then become a rarity.

The minutes of the late nineteenth, and also of the twentieth century, show much less concern with disciplining the membership as these responsibilities increasingly fell to be discharged by deacons and minister rather than the membership at large, and without minutes documenting their actions.

NOTES

- 1 All quotations are from the Loughwood church books, 1653-1900, deposited at the Devon Record Office, Exeter.
- Whilst the scriptures cited give examples of withdrawing from those who cause divisions and teach false doctrine, the authority for 'delivery to Satan' is not quoted but is probably from 1 Cor. 5.5 and 1 Tim. 1.20. Those verses, however, should be looked at carefully and in context: they refer to specific cases and not the sort of disciplinary action taken here.

With you in Synod we pray in God's presence that we may be granted the way to that unity and communion which are grounded in both truth and love; and that we may together share in the mystery of salvation.
