BIBLICAL AND THEOLOGICAL.

THE IDEALS OF THE PROPHETS. Sermons by the late Professor Driver, together with a Bibliography of his published writings. (T. and T. Clark. 3s. 6d. net.) In a preface which bears the initials of his successor, Canon G. A. Cooke, it is stated that Dr. Driver "has shown throughout his ministry that a modern Biblical scholar, one of the foremost champions of the new learning, a master in the science of language and criticism, could at the same time handle the Sacred Text with the reverence traditional among English people, and with his whole heart remain true to the Christian Faith, and fulfil his service as a loyal son of the Church."

OUR COMRADESHIP WITH THE BLESSED DEAD. By the Right Rev. J. P. Maud, D.D., Bishop of Kensington. (Longmans, Green and Co. 2s. net.) Five addresses given at St. Martin's, Trafalgar Square.

THE GOSPEL OF HEALING. By the Rev. A. B. Simpson, D.D. (Morgan and Scott, Ltd. 2s. net.) A volume designed to show that "the healing of disease by simple faith in God is a part of the Gospel and a doctrine of Scripture."

A PLEA FOR THE THOROUGH AND UNBIASSED INVESTIGATION OF CHRISTIAN SCIENCE. By C. H. Lea. (J. M. Dent and Sons, Ltd. is net.) A new edition, with special chapters on the Report on Spiritual Healing.

GENERAL.

THE ENGLISH CATHOLIC REVIVAL IN THE NINETEENTH CENTURY. By Paul Thureau-Dangin. Revised and re-edited from a translation by the late Wilfred Wilberforce, In two volumes, (Simphin Marshall and Co. 31s. 6d. net.) An extremely interesting book, showing an intelligent Fernchman's view of an important chapter in our ecclesiastical history, written with a fulness of reference which leaves nothing to be desired.

HINDUISM IN EUROPE AND AMERICA. By Elizabeth A. Reed. (G. P. Putnam's Sons. 5s. net.) The author, believing that converts to Hinduism are being made among Christian nations "because of roseate misrepresentations," gives us in these pages a picture of Hinduism as it really is. A most informing book.

DISESTABLISHMENT AND DISENDOWMENT UNDER THE WELSH CHURCH ACT. By S. E. Downing, B.A., LL.B. (S.P.C.K. 6d. net.) A careful analysis of the Welsh Church Act, written with great ability by the Secretary to the Ecclesiastical Commissioners.

CROWNED WITH GLORY. By the Rev. G. R. Oakley, M.A., B.D. (S.P.C.K. 18, 6d. net.) A collection of "stories of the younger Saints in the Prayer-Book Calendar"—viz., Prisca, Agnes, Agatha, Edward, Margaret, Faith, Katharine, and Lucy.

LONDON DIOCESE BOOK FOR 1915. Edited by Prebendary Glendinning Nash and Canon A. Glendinning Nash. (S.P.C.K. 1s. 6d. net.) Quite the best of all diocesan books, packed full of the right kind of information. No London clergyman or ecclesiastical layman should be without it.

WHY I JOINED THE CHURCH OF ENGLAND. By a Layman. With Foreword by the Bishop of London. (S.P.C.K. 2d.)

MY PRAYER-BOOK. Compiled by the Rev. H. F. Tomkinson. With Prefatory Note by the Archbishop of Canterbury. (Longmans, Green and Co. 3d. net.) Adapted for general use from "the Church Scout's Prayer-Book." We are sorry to see that it recognizes non-communicating attendance at the Holy Communion and also Auricular Confession. Truly the Archbishop writes wisely when he says "It will not suit everyone." We regret that he thinks "it will suit many."

WAR LITERATURE.

The War and Religious Ideals. By the Rev. C. L. Drawbridge. (Longmans, Green and Co. 1s. 6d. net.) A very welcome book. Atheists have not been slow to lay this war to the charge of Christianity. Mr. Drawbridge, who is better fitted than any man we know to answer unbelievers, has given us a volume which deals with the many questions raised by the war in a spirit of reasonableness. There are three chapters—(1) "The German Ideal"; (2) "The Survival of the Fittest"; and (3)—best of all—"The Christian Ideal and War." To anyone troubled with doubts on this question, Mr. Drawbridge's volume may be warmly commended.

The Shadow on the Universe. By I. M. Clayton, (Simpkin, Marshall and Co. 2s. 6d. net.) A volume written to prove that "warfare engenders a process of physical degeneration which must eventually bring about the extermination of the

human race." The discussion is more academic than practical.

CHRIST OR KAISER? THE GREAT WAR'S MAIN ISSUE. By Paul Tyner. (Victory Publishing Company. 3d. net.) The first of a series of pamphlets in the "Victory Series." The writer states that "this war is simply and certainly the duel to the death between Christ and Antichrist, between the Spirit of Truth and the Father of Lies."
