- Armstrong, John. "The Obedience of Faith," Trust and Obey: Obedience and the Christian. Edited by Don Kistler. Morgan, Pennsylvania: Soli Deo Gloria Publications, 1996, 79-117. This is a longer version of the complete revision included in this issue.
- Barclay, J. M. G. Obeying the Truth: A Study of Paul's Ethics in Galatians. Studies of the New Testament and its World. Edinburgh: T. & T. Clark, 1988. A helpful overview that grounds the reader in the world of Paul and the theology of Paul at Galatia.
- Barrett, C. K. Freedom and Obligation: A Study of the Epistle to the Galatians. Philadelphia: Westminster, 1985. A important readable treatment by a Testament scholar.
- Davies, Glenn N. Faith and Obedience in Romans: A Study in Romans 1-4. Journal for the Study of the New Testament Supplement Series 39. Sheffield, England: Sheffield Academic Press, 1990. More technical in style but highly useful.
- Donfried, Karl P. "Justification and Last Judgment in Paul," Interpretation 30 (1976): 140-52. A more technical version of this article appears in Zeitschrift für die neutestamentliche Wissenschaft 67 (1976): 90-110.
- Dunn, J. D. G. The Theology of Paul the Apostle. Grand Rapids: Eerdmans, 1998, chapters 5 and 6. Dunn will provoke and challenge you theologically but you will never come away from his work without an increased measure of insight into the text.

Fee, Gordon D. God's Empowering Presence: The Holy Spirit in

- the Letters of Paul. Peabody: Hendrickson, 1994. Fee is one of our best evangelical scholars and understands the dynamic work of the Holy Spirit better than most.
- Freed, Edwin D. The Apostle Paul, Christian and Jew: Faithfulness and Law. Lanham, Maryland: University Press of America, 1994.
- Garlington, Don. Faith, Obedience, and Perseverance: Aspects of Paul's Letter to the Romans. Wissenschaftliche Untersuchungen zum Neuen Testament 79. Tübingen: Mohr-Siebeck, 1994. If you choose one work by a New Testament scholar on this issue make it this very substantial work by Don Garlington. This is an expensive volume if you want to purchase it.
- Garlington, Don. "A Study of Justification by Faith," *Reformation and Revival* 11:2 (2002): 55-73. A very clear overview of a related issue to obedience and faith.
- *Garlington, Don. An Exposition of Galatians: A New Perspective/Reformational Reading. Eugene, Oregon: Wipf & Stock, 2003, 213-62. This edition is both accessible and important.
- *Gorman, Michael J. Cruciformity: Paul's Narrative Spirituality of the Cross. Grand Rapids: Eerdmans, 2001. I cannot say enough about the arguments of this book. Highly recommended.
- Koperski, Veronica. What Are They Saying About Paul and the Law? Mahwah, New Jersey: Paulist Press, 2001. This is a contemporary overview of the entire field of Pauline studies in contemporary New Testament research.
- Lowe, Chuck. "There Is No Condemnation" (Romans 8:1): But Why Not? *Journal of the Evangelical Theological Society* 42 (1999): 231-50. You can find this helpful article in a seminary library if you do not subscribe to JETS.
- Mott, S. C. "Ethics," *Dictionary of Paul and His Letters*. Edited by G. F. Hawthorne, et al. Downers Grove: InterVarsity, 1993, 269-75. The dictionary is valuable and this is a superb entry on Paul.

- Motyer, Steve. "Righteousness by Faith in the New Testament," Here We Stand: Justification by Faith Today. London: Hodder & Stoughton, 1986, 33-56. Hard for American readers to locate but worth reading.
- Packer, J. I. "Obedience," *The New Bible Dictionary*. Edited by J. D. Douglas. London: Inter-Varsity, 1962, 904-05. Exactly what you expect from Jim Packer—careful and wise insights abound.
- Perry, Edmund. "The Meaning of 'emuna in the Old Testament," Journal for Bible and Religion 21 (1953): 252-56.
- Soderlund Sven K. & N. T. Wright, editors. *Romans and the People of God*. Grand Rapids: Eerdmans, 1999. This is a collection written to honor Gordon D. Fee. Essays by N. T. Wright, James D. G. Dunn and I. Howard Marshall are worth the book!
- *Thompson, Michael B. The New Perspective on Paul. Cambridge: Grove Books Limited, 2002. A twenty-eight page booklet that explains the "new perspective" as fairly and concisely as anything available. (Order from Reformation & Revival Ministries at www.reformationrevival.com.)
- *Wright, N. T. The Climax of the Covenant: Christ & the Law in Pauline Theology. Minneapolis: Fortress, 1992. A collection of essays that offers a truly fresh voice in contemporary Pauline studies. Richard B. Hays notes, that "out of the carefully observed details, a bold new global construal of Paul the Jewish Christian theologian takes shape before our eyes."
- *Wright, N. T. "Romans" in *The New Interpreters Bible Com*mentary, Volume X. Nashville: Abingdon, 2002. This is the commentary many wanted after reading Wright's other material on Paul for nearly the past fifteen years. It will pay real dividends to the reader.
- *Wright, N. T. What St. Paul Really Said. Grand Rapids: Eerdmans, 1997. This insightful little book contains the best of Wright, in clear language, on the Pauline discussion regarding the obedience of faith. You do not have to agree

with him—and most will not at some points—to profit from his reflections on Paul.

Cambridge: Cambridge University Press, 1999. One of the most important works on the subject of the obedience of faith. This book is expensive but worth the money and time required to digest it.

Young, F. W. "Obedience," *The Interpreters Dictionary of the Bible*. Edited by G. A. Buttrick, et al. 5 volumes. Nashville: Abingdon, 1962-1976, 3.580-81. A very good supplemental piece.
