Evangelism Year Book 1968-1969. Published by the Baptist Union of Great Britain & Ireland, August 1968. 16 pp. 3s. 6d.

In magazine format and with a glossy four-colour cover this symposium consists of thirteen articles by as many contributors. Its stated aim is to provoke thought and action following the Presidential call to be "renewed for mission" with special reference to the possibilities for evangelistic action in Holy Week 1969. A brief foreword by the President commends the articles as having "something for everyone to adapt and apply". The writers represent a variety of ministerial experience and of theological viewpoint but they are one in their sense of urgency and concern for the effective communication of the Gospel in the contemporary world whether it be in the city, the new area or the village. At the outset there is a timely reminder that evangelism is the continuous function of the local church and that it is not to be restricted to special efforts. Nevertheless, it is recognised that there are seasons of special opportunity for which specific planning is necessary. So, while the Year Book has much to say about basic principles, attitudes and motives, there are several useful suggestions which will prompt ideas and action.

In the nature of the case such a publication lacks the continuity, cohesion and depth which would characterise a more substantial volume. But within its obvious limitations it is a useful document to put into the hands of local church leaders. The quiz on the place of organisations could produce a revolution! Some of the material might well form the basis of a series of sermons or house group studies. At the end of the magazine there is a list of relevant books with brief reviews.
