

## Isaac Mann's Collection of Letters

**B**EGINNING in January 1932, *The Baptist Quarterly* (VI, 39ff.) published a "Calendar of Letters, 1742-1831, collected by Isaac Mann". These letters had passed through several ownerships prior to their acquisition by the National Library of Wales (M.S. 1207. E). Compiled by the Rev. F. G. Hastings, the calendar amply demonstrated that the two hundred letters contain valuable information about leading Baptists of this period. Recently, a similar group of letters, equally varied and interesting, and almost certainly an additional part of Isaac Mann's collection, has come to light in the Osborn Collection of the Yale University Library. These letters, eighty-six in number, provide vivid insights into the lives and concerns of certain late eighteenth and early nineteenth century Baptist leaders.

John Ryland and Abraham Booth are represented in this group of papers by eight and six letters, respectively, and William Carey, Christmas Evans, Andrew Fuller, and Samuel Pearce are represented by several items. Letters of four members of the prominent Stennett family of preachers are also present, including Joseph Stennett's farewell letter, written two months before his death to his congregation in Little Wild Street, and his son Samuel's letter accepting the call to succeed his father. Other Baptist leaders such as John Sutcliff, William Paxon, and Isaac Mann are among the recipients of the letters. The remaining items include letters or other documents of several Independent divines.

While there is no conclusive proof that Isaac Mann collected these letters, certain evidence supports this hypothesis. Five of the letters, for example, are addressed to Mann, and three of these relate to his autograph collecting. Two other letters bear endorsements in Mann's hand, attesting to the validity of handwriting specimens of eminent ministers. Thus it seems highly probable that these manuscripts were once part of his collection but were separated from it in the nineteenth century, presumably before W. Thomas Lewis sorted and arranged the main body of the collection (see the introduction to the calendar of 1932).

The subsequent ownership of the newly discovered segment of the Mann collection remains obscure. Sold anonymously at Sotheby's in London on 6th February, 1973 (lot 353, listed among "Other Properties"), the Mann letters comprised less than half of a catalogue lot of clerical autographs ranging from Philip Henry to Cardinal Wiseman. On sorting these diverse materials it became apparent that one significant group of letters possessed a unity which suggested a common origin. Thus, a lost portion of the Isaac Mann collection has been recovered.

The following list is arranged alphabetically by author. The convenient abbreviation "ALS" identifies an autograph letter, signed. Each description also provides the date, within square brackets if inferred, and the place from which the letter was written. After a statement of the pagination, which includes only the pages bearing text, I have added a brief summary of the content of each letter.

## Reviews

*Internationale Zeitschriftenschau für Bibelwissenschaft und Grenzgebiete: International Review of Biblical Studies: Revue Internationale des Etudes Bibliques.* Band XX. 1973/74. Düsseldorf. Patmos-Verlag. Pp. xiv + 464. No price.

This international review magazine continues its valuable service to scholars and students of Biblical studies and of related fields of research. Over the years this publication has grown in size so that the present volume contains no less than 3,217 entries derived from some 600 periodicals, *Festschriften* and other books, representing the contribution of some 2,500 authors. It has been prepared by a team of 64 scholars. These figures speak for themselves, and there is no doubt that this truly international review has become an essential bibliographical aid and an extremely useful guide for students of Biblical problems. Each bibliographical entry usually provides a very concise summary or outline of the article or book referred to, but it is not
